1. I am 18 years of age or older and have read, understood and agreed to the terms below.
2. I agree adopt the pet described above, and understand there is a settling in period of 4 weeks from the date of this application (**Settling In Period**).
3. No Representations. You understand that this Cat was previously unwanted or lost and may have been rescued from a dangerous, unhealthy and/or cruel situation. This could result in the Cat's emotional or physical illness. You agree that we are making no representations or warranties about the temperament, personality or condition of the Cat.
4. I agree to maintain and house the pet in conditions explained to me by DoggieRescue.com. The pet will become a member of our family and as such will be cared for with the comforts of home.
5. Veterinary Care. You agree to have the Cat regularly examined by a licensed veterinarian to maintain it in good health. In the event of illness or injury, you agree to seek prompt veterinary care. You agree to keep at minimum the standard F3 vaccinations current according to Veterinary Association guidelines.
6. The information I have provided to DoggieRescue.com as to the property on which the pet is to be housed and my ability to maintain the pet in proper health is true and not misleading in any way.
7. If, during the Settling In Period, I feel the pet is unsuitable for any reason, I will contact DoggieRescue.com and arrange a mutually convenient time to return him/her and all relevant paperwork to DoggieRescue.com.
8. I understand that DoggieRescue.com may before or during the Settling In Period inspect the property on which the pet is to be housed to ensure the pet's safety and security and that as a result of this inspection I may be requested by DoggieRescue.com to return the pet. I agree to return the pet if requested to do so by DoggieRescue.com at a mutually convenient time and place.
9. The cat will, at all times, wear a collar with an identification tag attached during the Settling In Period. The cat, will not be allowed off my property or allowed in any unsecured area without a collar.
10. I indemnify DoggieRescue.com, its directors, employees and volunteers for any liability, costs or expenses which arise as a result of my actions or omissions (including negligence) or the pet's condition, health or behaviour whether during or after the Settling In Period and acknowledge that DoggieRescue.com is not liable or responsible for the pet after the date of this application.
11. Sterilization. If the Cat has not been spayed or neutered prior to this adoption, you agree to enter into a Sterilization Agreement with us simultaneously with this Agreement, and to have the Cat sterilized in accordance with the terms and conditions of the Sterilization Agreement.
12. Adoption Fee. We require an adoption fee of \$_____ for the Cat, to help defray our expenses for the Cat's food and veterinary care. We have a very limited budget. The adoption fee is not refundable under any circumstances.
13. Transfer; Euthanasia. You agree not to abandon, give away, sell or dispose of the Cat in any way and to notify us immediately at any time you determine you no longer want, or can no longer keep the Cat. You further agree that DoggieRescue.com will have the first option to take the cat back. You agree that you will never surrender the Cat to any animal shelter or any other animal adoption organization. You agree that you will not euthanize the Cat except in the case of terminal illness or injury, and in that event, a licensed veterinarian must perform the euthanasia.
14. Lost Cat. You agree to make a serious effort to find the Cat if it becomes lost, by immediately (a) filing lost reports with the local council, pounds, animal shelters, and local veterinarians, (b) posting lost cat signs and (c) contacting us for additional advice.
