and undertake as follows:

1. I am 18 years of age or older and have read, understood and agreed to the terms below.
2. I agree to accept the cat described above until she/he is permanently adopted, unless the cat is returned to DoggieRescue.com in accordance with these terms.
3. I have inspected the cat and agree to accept the cat in its current condition, health and behaviour. I have not relied upon any representation by DoggieRescue.com in deciding to foster the cat.

CONDITIONS OF CARE:

4. I agree to maintain and house the cat in conditions explained to me by DoggieRescue.com. The cat will become a member of our family and as such will be cared for with the comforts of home.
5. The information I have provided to DoggieRescue.com as to the property on which the cat is to be housed and my ability to maintain the cat in proper health is true and not misleading in any way.
6. **I agree not to house the cat at an alternative location or pass the cat into the care of another person, without the express consent of DoggieRescue.com**
7. **I agree not to take the cat out of the greater Sydney region without express consent of DoggieRescue.com**
8. I understand that DoggieRescue.com may before or during the Fostering Period inspect the property on which the cat is to be housed to ensure the cat's safety and security and that as a result of this inspection I may be requested by DoggieRescue.com to return the cat. I agree to return the cat if requested to do so by DoggieRescue.com at a mutually convenient time and place.
9. I agree to continue monthly flea treatment (due 1st day of every month), and quarterly gastro-intestinal worming treatment.
10. **The cat will, at all times, wear a collar with an identification tag attached and be kept indoors ONLY.**

COSTS:

11. I agree to pay the \$200 fostering bond for the cat, and I understand this is refundable upon his/her adoption.
12. I understand that all day to day costs associated with the care of the cat (such as food, worming and tick treatment – preferred worming products are Milbemax or Drontal or talk to your foster coordinator to discuss any flea/tick treatments preferred) are my responsibility and cost.
13. I understand that if the cat is due for annual vaccinations (see date over) I must contact DoggieRescue.com. I agree to take the cat to a vet appointed by DoggieRescue.com for vaccination, and I understand that this cost will be covered by DoggieRescue.com

- 14. If I return the cat for any reason prior to a permanent home being found, I agree that this \$100 bond be retained by DoggieRescue.com as my contribution towards kenneling and any other costs.
- 15. I agree to make regular (fortnightly) contact with my Foster Coordinator to provide an update on the well-being of the cat.
- 16. I agree to contact the Foster Carer immediately if the cat is sick, injured or experiencing difficulties settling in.
- 17. I agree to advise my Foster Coordinator should the cat require any veterinary treatment. I understand that veterinary costs will be covered by DoggieRescue.com but only with prior approval from DoggieRescue.com
- 18. I agree to advise my Foster Coordinator if I require any short-term assistance to house the foster cat due to planned holidays etc. I will provide as much notice as possible.

ADOPTION ENQUIRIES:

- 19. I understand that should the Foster Coordinator receive adoption enquiries about the cat, I will be contacted.
- 20. I agree to make the cat promptly available for inspection at a mutually agreeable time and location, and to I agree to actively participate in the adoption process if required.
- 21. I understand that should another party be interested in adopting the cat, I may apply to keep the cat however this is subject to the terms and conditions of adoption, and payment of the full adoption price for the cat.

RETURN OF CAT:

- 22. I agree to return the cat to DoggieRescue.com upon request.
- 23. If during the Fostering Period I feel the cat is unsuitable for any reason: a) I will contact my Foster Coordinator and arrange a mutually convenient time to return him/her to DoggieRescue.com and b) if I return the cat for any reason prior to a permanent home being found, I agree that this \$200 bond be retained by DoggieRescue.com as my contribution towards kenneling and any other costs.
- 24. I indemnify DoggieRescue.com, its directors, employees and volunteers for any liability, costs or expenses which arise as a result of my actions or omissions (including negligence) or the cat's condition, health or behaviour and acknowledge that DoggieRescue.com is not liable or responsible for the cat after the date of this application.
- 25. I have read, understood and agreed to the terms contained within the DoggieRescue.com Foster Care Agreement.
- 26. I will **notify DoggieRescue.com within 7 days of any change to my contact details** recorded above.
